

TERMS AND CONDITIONS

1. The company »Srnica park pustolovskih doživetij, Nela Vitez s.p.«, Kot 11, 5230 Bovec (shortened »Srnica Nela Vitez s.p.«) organizes the guided Tours in the gorge »Srnica«, carry out with professional guides authorised exclusively by »Srnica Nela Vitez s.p.« company.

SAFETY

- 1. The Tour BEGINS upon guests arrival at the prior agreed meeting point, or at the sport agency »Outdoor Galaxy«, Kot 1, 5230 Bovec. The Tour ENDS when all participans safely return back at the prior agreed meeting point, or at the sport agency »Outdoor Galaxy«. »Srnica Nela Vitez s.p« , cannot be held liable for any injury whatsoever which may occur outside of the duration of the Tour as outlined above.
- 2. Participans are expected to be physically and physiologically fit and not influenced by any psychotropic substance.
- 3. The Tour is strongly adviced against for pregnant women or the individuals with serious medical concerns. Anyone with medical issues, must inform their tour guide prior to the beginning of the Tour.
- 4. »Srnica Nela Vitez s.p«, is not responsible for any injuries resulted of a breach outlined in the signed declaration or because the participant's violations instructions directed by tour guide. Signature of statement is obligatory.
- 5. On the Tour we strongly advised aginst wearing jewelry, wrist watches, glasses, video or still cameras. »Srnica Nela Vitez s.p«, shall not be be held responsible for loss, thelft or damage of any personal property or belongings.
- 6. The actual Tour guide must be notified on spot if any serious injury occurs. In such accident during the Tour, the participant and all witness presented, should file appropriate accident report. »Srnica Nela Vitez s.p« is not to be held responsible for any injuries noted or reported, after the Tour is finished.

RESERVATIONS

1. Reservations are accepted directly over the counter in the sport agency »Outdoor Galaxy«, by phone or via e-mail.

CANCELLATION OF THE TOUR

- 1. »Srnica Nela Vitez s.p.« reserves all rights to cancel, postpone or terminate the Tour based on objective or subjective safety concerns. In the event of a cancellation by »Srnica Nela Vitez s.p«, the company is due to refund all respectable guests in full.
- 2. In the event of a individual cancellation of the Tour by the guest, AFTER receipt of mandatory equipment, we do not return money. We do not refund if the Tour is shortened due to poor physical or psychological preparedness of the clients and also in the case of sudden, unusual weather conditions which could severly affect the safety of the Tour.

CANCELLATION OF THE RESERVATION

In case of cancellation of reservation by the client side, the refund rates are:

- -30% of the reservation fee up to 15 days before the start of the Tour.
- -50% of the reservation fee between 14 and 8 days before the start of the Tour.
- -100% 7 days or less before start of the Tour, there is NO refund of reservation fee.
